- **Nonexclusive License.** Speaker hereby grants AHLA a royalty-free nonexclusive license, on a commercial and noncommercial basis, to use, modify, publish, reproduce, prepare derivative works, distribute, publicly display, and archive any and all written, electronic, video, recorded, or graphical material that Speaker presents or submits in connection with the Event (collectively the “Presentation Materials”), in whole or in part, in all forms of media including but not limited to electronic rights. Speaker grants AHLA a right of first publication in the Presentation Materials, and therefore, Speaker cannot publish the Presentation Materials elsewhere until AHLA has published the Presentation Materials.
- **Speaker’s Rights.** Speaker understands that he/she retains ownership of the Presentation Materials; however, Speaker further understands that AHLA shall retain all intellectual property rights in any resulting media that utilizes the Presentation Materials. Speaker also understands that this Speaker Release Form does not prohibit Speaker from using the Presentation Materials in the future in Speaker’s professional or personal work subject to AHLA’s right of first publication.
